

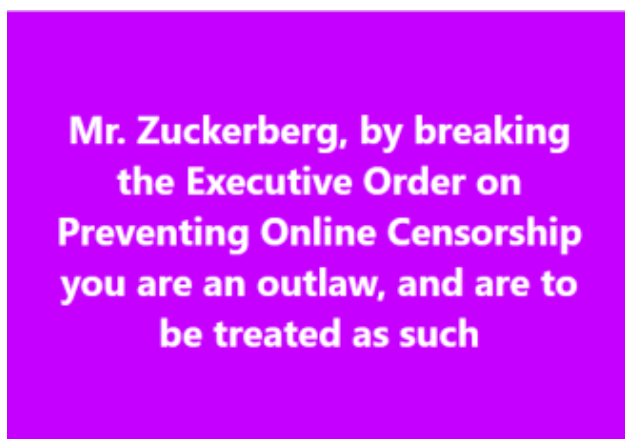
# Refuz botnița sclaviei noii ordini mondiale
